- ① Submit completed application.
- 2 Submit initial Home Occupation fee \$50.00 or Renewal fee \$25.00
- The application will be reviewed and you may be contacted to schedule an inspection of the premises within fifteen (15) days.
- You will be notified in writing of either approval or denial of the Home Occupation request. If approved, the Home Occupation Permit is valid for a period of one (1) year from the date of approval. If denied, you may appeal the decision to the O'Hara Township Zoning Hearing Board.

RENEWAL:

Home occupation permits may be renewed annually provided there has not been any violation of the provisions of O'Hara Township Code Chapter 455 (Zoning), Section 14.22. Requests for renewals shall be submitted to the Zoning Officer, in writing, accompanied by a renewal fee of \$25.00 one (1) month prior to the expiration of the permit. Payment may be made by check, money order, or if paying with credit card you must present it at the Township building.
