Manager Jakubec stated the purpose of the public hearing is to receive public comments from residents and others regarding the proposed Zoning Ordinance Amendments. As proposed, the amendments will assist in the revitalization of the RIDC Park. The proposed changes include:

Add as a Conditional Use:

Supplemental Regulations:

No audio emitted from fuel pumps or EV Supply Equipment, except for store communications:

Any proposed use shall have a driveway entrance located within 600' of a highway interchange or parcel that abuts a State Road and has direct access to the State Road for ingress and egress:

Building site shall not abut a residential district.

Primary Building shall be 300' from a residential district or any adjacent municipal border.

EV Charging (DC / Fast Charging)

EV Charging (DC / Fast Charging) uses shall not reduce the number of required parking spaces required by the Principal Use:

Stations shall comply with the setback requirements associated with parking lots:

Any canopy or covers must meet setback requirements for the Principal Structure.

The proposed amended zoning ordinance was forwarded to Allegheny County Economic Development for review and comments, which have been received. The ordinance was introduced during the December 12, 2023 regular meeting.

Manager Jakubec provided additional information for the Girl Scouts that were in attendance.

Treasurer Caprara asked if canopy coverings included regulations for solar panels. The Manager explained that solar panels are covered under the Alternate Energy ordinance.

Mr. Cullen questioned if post-secondary education should have some form of accreditation. Manager Jakubec noted boot camp, and computer program educational entities may or may not offer accreditation and did not know what type of accreditation should be required.
