The regular monthly meeting of the O'Hara Township Zoning Hearing Board held on Monday August 7th, 2023 at the O'Hara Township Municipal Building located at - 325 Fox Chapel Road, Pittsburgh, PA 15238.

Chairman Scott Duffy called the meeting to order at 7:00 PM.

ZONING HEARING BOARD CASE NO. 1249

Mr. Scott Duffy – reads the case description: Industrial Testing Laboratories wishes to obtain the necessary variance for the size of building mounted signage at 635 Alpha Drive, Block and Lot 226-L-110. The subject property is located in an "SM" (Suburban Manufacturing) Zoning District. As proposed, the request violates the Code of The Township of O'Hara, Zoning Chapter 455, Section 455-16.4.D
